This Supplement (the "Supplement") constitutes a Supplement to the Prospectus for the purposes of Article 23 of Regulation (EU) 2017/1129 (the "Prospectus Regulation") and is prepared in connection with the Euro Medium Term Covered Note Programme (the "Programme") established by AB Sveriges Säkerställda Obligationer (publ) (The Swedish Covered Bond Corporation) (the "Issuer"). This Supplement is supplemental to, and should be read in conjunction with, the prospectus relating to the Programme dated 22 March 2024, as supplemented by the Supplementary Prospectus dated 3 May 2024 (the "Prospectus") which comprises a base prospectus for the purposes of the Prospectus Regulation. Terms defined in the Prospectus have the same meaning when used in this Supplement.

This Supplement has been approved by the Central Bank of Ireland as competent authority under the Prospectus Regulation. The Central Bank of Ireland only approves this Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation. Such approval should not be considered as an endorsement of the Issuer or the quality of the Notes that are the subject of this Supplement. Investors should make their own assessment as to the suitability of investing in the Notes.

The Issuer accepts responsibility for the information contained in this Supplement. To the best of the knowledge of the Issuer the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

Purpose of this Supplement

The purpose of this Supplement is (a) to incorporate by reference the unaudited interim financial statements of the Issuer for the six months ended 30 June 2024, including the audit review report thereon (the "2024 Interim Results") and (b) to include a new "Significant or Material Change" statement.
